# Minutes taken by Co-secretary, Liam:

Koko Booster Club meeting notes June 12, 2023; 1735 meeting begins. Present are temporary President Steph, Secretary Liam. Items for discussion are incorporation documents, that Steph drafted, and primary and secondary dates for golf fundraising. October 9 proposed as primary, October 16 as secondary. 6 votes in favor of both (out of 9 total at this Booster meeting). Next steps are to inform Kaui, create flyers, and get Kaui guidance on next steps. Steph agreed to contact Keith, the POC at Hawaii Kai golf course. Steph recommends at least one person shadow Kaui, perhaps from fundraising committee, or from Booster Board. Beto Ramirez suggested as person that could shadow and work with Kaui (he is a golfer).

Next meeting? Steph is out of town the next three weeks. Info from Kaui will help inform on next steps. Booster Club will ask for \$25 or \$26 from Koko as "seed money" to pay fees to incorporate Booster Club.

Next item: to incorporate and formalize our organization, to file Articles of Incorporation to be a non-profit in State of Hawaii. Steph created draft Articles of Incorporation, listing Stephanie Jurgenson and Liam Connel as the members. Once filed, this will allow us to open a bank account for Booster Club. But we then also need to create our own articles (aka "by-laws") to ensure we qualify for tax exemption status. We may want to align these with those of the gym, that is also a non-profit. Steph created a draft articles/by-laws.

Regarding minutes from the last meeting, process would be for a proposal to approve, then a second, and then a vote – we will do a vote to approve meeting notes for June 5 and June 12 meetings, at our next meeting (date is still TBD).

Four of five board members present at June 12 meeting – Temporary President Stephanie Jurgenson; Treasurer Tiara Kalopodes-Faagata, secretaries Liam Connel and Anja Loomis. Articles/by-laws, once finalized, will likely require 3 of 5 board members present for board to make decisions.

Discussion was had on what bank to use; consensus is to use First Hawaiian, consistent with Kokokahi Gymnastics Team. Concern raised that we as Kokokahi Booster Club would be confused with Kokokahi Gymnastics Account, so name with bank should be clear that we are a different/separate entity.

President Stephanie said she plans to pay the \$25 filing fee with her personal funds, and then seek re-imbursement from the Booster Club (who may at that point have "seed money" from Kokokahi Gymnastics). Stephanie may file and pay as soon as tonight.

Stephanie Jurgenson and Liam Connel signed Articles of Incorporation.

Next meeting TBD, meeting adjourned at 1800.
